

Guidelines for Submitting a Citizen Warrant Article

Open dates for submission of citizen warrant articles are advertised each fall for the next **ANNUAL TOWN MEETING WARRANT**. For further information, please call 228-7255.

Your proposed warrant article must:

- State the section of the *Code of the Town of Nantucket* that you would like to amend, if appropriate.
- State what language is to be deleted, changed, or added as appropriate.

Citizen articles require the signatures of at least ten (10) registered voters of Nantucket.

The first name/signature following the article shall be the sponsor of the article; the sponsor's name is published in the warrant, and the sponsor shall be responsible for representing the article at Town Meeting, if necessary.

Note: Citizen articles will be printed in the warrant as submitted, including any typographical or other errors.

Sample 1: Zoning Bylaw Amendment

To see if the Town will vote to amend Chapter 139 (Zoning), Section 18A (Off- street parking requirements), sub-section (1) of the Code of the Town of Nantucket as follows:

Delete the following sub-section:

- (1) For the purpose of this Section 139-18, an enlargement of any building shall require the provision of off-street parking for the existing building when enlarged as if it were newly constructed.

And replace it with the following sub-section:

- (1) For the purpose of this Section 139-18, an enlargement of any building shall require the provision of off-street parking for the existing building as if it were newly constructed when the use of the structure is changed and/or the enlargement of the structure requires additional parking.

Sample 2: Bylaw Amendment

To see if the Town will vote to amend §105-16 (Street Performers, Permit required) of the Code of the Town of Nantucket, as follows: (*NOTE: new language is shown as highlighted text; language to be deleted is shown by strike-out; these methods to denote changes are not meant to become part of the final text*):

Article V

Street Performers

105-16. Permit required.

- A. A street performer's permit shall be issued by the town to each applicant therefore in exchange for a completed application and a fee of ~~twenty-five dollars (\$25.)~~ **fifty dollars (\$50.)**
