

**PURSUANT TO M.G.L. CHAPTER 30B THE TOWN OF  
NANTUCKET IS DECLARING THE AVAILABILITY OF  
SLIPS AT THE TOWN PIER FOR THE 2011 BOATING  
SEASON  
PUBLIC NOTICE  
2011 Town Pier Slip Lottery**

Requirements for eligibility are: A copy of a valid Massachusetts boat registration or Federal documentation papers.

Commercial Slips

Applicants for the four (4) commercial slips must provide proof that the vessel's home port is Nantucket, commercial documentation that the vessel is actively engaged in commercial fishing, charter, or marine trade related activity. i.e. tax return schedules, fishing vessel trip reports, proof of commercial insurance, business profile. Slips will be assigned as three (3) slips dedicated to *commercial fishing/charter for a one year agreement*, (1) slip for *marine related businesses for a one year agreement* (mooring company, boat yard, boat repair/sales facility).

Old Town Pier

There are 54 slips available for recreational boats up to and including 30 feet. Due to Federal guidelines parking spaces in the Town Pier parking lot are included with these slip assignments **ONLY**.

### Town Pier Expansion (floating dock)

Additional recreational slips are available, some of which will accommodate boats 31 feet-40 feet. The remaining slips will be assigned based on length and draft.

### Handicap

There are two (2) handicap accessible slips available. Applicants will be drawn separately and assigned accordingly. **Mark application clearly for handicap slip.**

### Time period

*May 1 – September 30, 2011.* Recreational slip rental fee: \$75.00 per foot for the five-month season. (e.g. 23 FT X \$75.00 = \$1,725.00). Commercial slip rental fee: \$100.00 per foot for the five-month season. e.g. 30 FT X \$100.00 = \$3,000.00). Applications must be received at the Marine & Coastal Resources Department office prior to 4:00 PM on March 30, 2011. The lottery will be conducted using either the valid boat registration number or Federal documentation number, not by applicant name, to avoid duplication. Applicants not chosen will automatically be placed on a waiting list and assigned slips if available. Individuals having slip assignments in 2010 will automatically be included in the 2011 lottery *provided that proper information is on file*. The Harbormaster reserves the right to assign slips based on length, draft, beam and type (sail/power) of vessels selected.

The lottery will be held at 11:00 AM, April 1, 2011 in the Town Building, Conference Room, 16 Broad Street, Nantucket, MA.

***FULL PAYMENT AND PROOF OF INSURANCE MUST BE PROVIDED BY MAY 1, 2011 if your boat is chosen.***
