Concerns (1:04)	Williams – Overview of owners’ concept. Presented project. Oliver – She reviewed all of these and has no concerns. Rear doors to be 6-light to match the 2-over-2 windows Coombs – No concerns. Camp – The gable windows should all be 4-lights. Thornewill – Nothing to add. Welch – These are sensitive and well designed. There are some topographical changes; if there’s anything dramatic and air conditioning should come back with the landscape plans. Pohl – The approval would be for architecture alone with retainage applied for and approved separately.

Other Business	<ul style="list-style-type: none"> • Next HDC Meeting-Tuesday, March 29th at 5:00PM Hybrid at Public Safety Facility. • Discussion of Advisory Board review: <ul style="list-style-type: none"> Martinez – Got those meetings scheduled so they review their projects well before the HDC meeting. • Section 106 – Sunrise Wind Farm Project, Intro: <ul style="list-style-type: none"> Backus – Ms. Coombs was elected to represent the HDC in these hearings. The Town has expert counsel to work on this. Welch – There’s a new project on the horizon. Norton – The Park City Wind project, which has applied to Conservation Commission, is continued to their April 7 meeting. Backus – Park City Wind, LLC is also known as Vineyard Wind South. She will get what information she has to Ms. Coombs. • Discussion of additions and new dwellings added to the consent agenda <ul style="list-style-type: none"> Welch – He asked this be put on the agenda for discussion and explained his reasoning. When the links to the applications go out, there is an invitation asking commissioners to look at them and recommend if they think something should go on consent. Pohl – The consent agenda is a series of recommendations and if any voting board members don’t think an item should be on consent, it can be pulled. Backus – Asked about the issue of abutter notification. Coombs – Many times we’ve heard an abutter didn’t get the notification until the day before the meeting. Every member of this board has their own opinion of what is and is not important and people count on a project to be reviewed by a full board. Consent items aren’t being reviewed by a full sitting board. Camp – She would like to be part of the team that reviews applications for consent. With pools and new dwellings and for the benefit of the abutter, she doesn’t mind spending the time to review that project. There are other things we deal with beyond the architecture alone. Oliver – All members are provided links to the projects; there is no subcommittee working to put things on consent. Pohl – The abutter notification system is flawed but the members of HDC can’t be responsible for that. Legally, two members of HDC can approve an item. He’s going to check with Ms. Martinez on the process for setting policy regarding consent. • Review policy of Move/Demo hearings in relation to new dwellings • Hardscaping • Discussion of salvaging demos • Discussion of options for house moves
