**Expected ACK Security and Screening Requirements for Passengers and Flight Operators**  
**November 23<sup>rd</sup> to November 28<sup>th</sup>**  
**Subject to Change w/o Notice**

Agency security requirements will result in the following temporary changes to Airport security screening requirements for all Passengers and flight crews (including transient General aviation). Flight operators should contact official sources for updates, and passengers should contact their flight operator for the most relevant information.

**Airport-Based GA Tenants:**

- **Will** be required to enplane via temporary security screening checkpoint in the Terminal (Non-secure Baggage claim A).
- Will **not** be given ATC taxi instructions unless cleared according to the filed TFR.
- **Will** be subject to announced/unannounced ramp freezes that will require hanging aircraft (or returning to tie down), closing hangar doors, and/or leaving the airfield.
- **May** be subject to ramp checks/aircraft security inspection by designated law enforcement/security personnel.
- **May** be subject to Gate 8 announced/unannounced freezes.

**Airport-Based Secure and Non-Secure Part 135 Operators with Active Security Plans (Cape Air, Southern Airways, FedEx/UPS/Wiggins)**

- **Will** deplane crew and PAX through lease-identified areas as customary.
- **Will** be subject to announced/unannounced ramp freezes/ramp checks by designated law enforcement personnel.
- PAX and Crew **will** be required to screen/rescreen on departure through existing TSA security screening/Secure Hold Room.

**Transient General Aviation Passengers and Operators, Part 135 Operators w/o Active Security Plans**

- **Must** deplane through the FBO: no on-ramp escorts are available.
- Passengers **and** Crew **must** screen through the temporary TSA security checkpoint in Baggage Claim A.
- Flight crew member/PIC **must** also check-in at FBO for services/payment.
